CHAIRMAN'S CORNER

Welcome to the Autumn 2016 edition of Knoll News. The most important news is that the Association's 42nd AGM will be held on Tuesday, 22 November in the Morton Hall at St John's United Reformed Church at the corner of Mayfield Avenue and Lynwood Grove. Proceedings start at 7.45 and we look forward to welcoming all members on the night. Please make a note in your diaries.

As usual, the evening will start with a small amount of formal business (see Agenda on back page) but will quickly move on to the most important part of the evening – the chance to hear and question our guest speakers and local Councillors about issues which affect the Knoll area and which matter to you. We always try to get interesting and relevant speakers. This year we have:

- · Sally Pennington from the Orpington Priory Community Hub; and
- Sharon Baldwin from Orpington Business Improvement District ("BID") to talk about the latest developments on the High Street.

The Orpington Priory Community Hub is seeking to take over the running of the Priory Building, which was the old Library and Museum, from LBB and turn it into a community asset. It has some exciting plans and is hoping for Lottery funding to help turn them into reality. On the High Street, this year has seen the opening of the cinema and hotel and we are all interested in future plans to reinvigorate Orpington.

We will also have representatives from our local Councillors, who will be on hand in the general question and answer session that follows our guest speakers to answer questions about Bromley Council actions and what is happening in and around the Knoll area.

As usual the meeting will conclude with drinks and light refreshments. This gives us all a chance to talk to Councillors, guest speakers, members of the KRA Committee and, of course, friends and neighbours in a friendly and informal setting.

A copy of the Agenda is on the back page. Copies of the minutes of last year's AGM are available on our website (www.kra.org.uk) and will also be available on the night. Copies of the Association's accounts for the year to 30 September 2016 will also be available on the night. I and the rest of the Committee look forward to meeting as many members as possible at the AGM, so please make a note in your diaries and come along.

ASRC

As mentioned in the Summer edition of Knoll News, the original LBB response to our petition for most of our area to be made an ASRC ("Area of Special Residential Character") was to restrict the area to part of Dalewood Road, part of Broxbourne and (all of) Lynwood Grove and Mayfield Avenue. This was based on a very detailed review of the roads we asked to be included in the ASRC, including descriptions of the type and style of houses in the road, the extent to which the roads were wooded, comments on front gardens etc., accompanied by photographs of "typical" houses and the area in general.

The reasoning behind LBB's decision was that the new criteria for becoming an ASRC (these have changed and become more restrictive since we undertook the petition) include a requirement for properties to be of a "similar style" and, while the properties inside the Dalewood/Broxbourne area are arguably reasonably homogenous in style, those outside that area are more diverse.

We met with Council Officers on 27 April to discuss the position and as a result I am pleased to say it appears that at the time of writing (23 September) LBB have now agreed to extend the area to include most of Dalewood (excluding the newer build houses towards the station), nearly all of Broxbourne and the various closes and roads off Lynwood and Mayfield. This extends the original area put forward by LBB by about 25%.

In consultation with our local Councillors for Knoll and Petts Wood, we have carefully considered what, if anything, we should do further. Given that the criteria for becoming an ASRC have changed since we originally set in motion the petition, we have reluctantly come to the conclusion that we are unlikely to be successful in persuading Council officers to extend the ASRC further. Provided that the revised boundaries are incorporated in the draft version of the Local Plan that should be public by the time you read this, we therefore will accept the Council's proposed boundary.

SITUATIONS VACANT

POST OFFICE CLOSURE

Amidst the good news about the High Street - the cinema and the hotel etc - we also have some bad. The Post Office has announced that it intends to close down the existing Post Office in Orpington High Street and move the facilities over the road into WH Smith. The new "office" will be at the rear of WH Smith and will still be a Crown Post Office with 5 serving positions, although how many will be "open" is, of course, another matter. The move is intended to take place in February 2017.

Presumably this is the case of two struggling organisations seeking to help each other out. The Post Office has a consultation portal for comments on the proposal (comments@postoffice.co.uk; use code 007012), although past history (the Post Office in Beckenham is now located in WH Smith) suggests that the move will take place regardless.

Equally important, however, is the question of what will happen to the old premises. Presumably the Post Office will seek to sell them to raise money but as the premises are one of the more presentable buildings along the High Street, but maybe not easily adaptable to other purposes, there is a real concern that the purchaser may seek to knock them down or at least significantly change them.
