Hello Knoll Residents, hope to find you all well. Firstly thank you for taking your time in reading this Crime Update, if you wish to contact us for any reason please call or email your team using the details as shown below.



Over the past few months we are happy to say that our crime in the area has dropped significantly due to lockdown as residents have been at their properties more, that's not to say that we haven't had crime reported however we have noted just recently that with Schools having gone back and people returning to their places of work we have now started to see an increase in reported crime.

At this time of the year as we start to see the dark evenings drawing in and the clocks going back it's pretty certain that our reported burglaries will start to increase, on this we ask that residents start to set their house ALARM SYSTEMS when they leave their properties, AND during the night when their tucked up in bed asleep, also if you do have to leave your property then think about leaving lights on or purchase a couple of timer switches, a house in complete darkness is a giveaway sign that no-one may be at home. Make sure that you double lock your doors and secure any open window before you turn in for the night, also remove any keys that may be in the back of doors.

Don't leave valuables on display in vehicles, a car may be broken into even if it's just for a bit of loose change. People take unnecessary risks leaving their engine running to let their cars warm up on cold winter mornings, criminals are also up early too.

If you are an owner of a KEYLESS CAR ENTRY system then think about purchasing a FARADAY POUCH, which will block any signal to your vehicle keys.

When using ATMs be aware of what's happening behind you, if possible go inside the premises to withdraw your cash. When out and about be careful when using your mobile phone, holding that expensive mobile phone up to your ear is just like holding up a bunch of ten pound notes to the criminal who will think nothing about attempting to snatch it away from you.

Planning news: Orpington 1st update on Walnuts development

Orpington Town Centre Public Consultation: The public consultation for the future of Orpington Town Centre closed on 5 October. Recurring themes in the public comments included pedestrianisation; provision of free parking; provision of toilet facilities and a café to encourage visitors to Priory Gardens; and an update to the Walnuts market square area to include box-park style facilities, space for more community events and pop up innovation. The outcome of the consultation will help shape 'Supplementary Planning Documents' (SPDs), which will provide detailed guidance to complement the policies already outlined in the adopted Local Plan and will be a material consideration in the determination of relevant future planning applications. The next step is for the Council to prepare the draft SPDs, which will be subject to a further round of consultation in early 2021.

Proposed Development of Poundland: KRA Committee members met with Acklam Developments to discuss their plans for the redevelopment of 208-212 High Street (former Poundland), which tentatively include reconfigured flexible ground floor retail space, around 44/45 apartments (1, 2 and 3 bed) and 20 parking spaces. We discussed parking provision to protect the already congested High Street and surrounding residential roads. We also discussed plans for sound proofing and screening the apartments to prevent future noise complaints from residents, thereby safeguarding the outdoor facilities of existing neighbouring businesses (The GPO and Pato Lounge). Acklam Developments took our comments on board and the Committee left the meeting feeling positive about the development. We await the submission of their formal plans to the Council for Planning Permission.

Residents are asked to not light Bonfires during the COVID19 pandemic

In an update to our previous newsletter request to all residents to consider the effects that bonfires have on their neighbours, we are once again asking you to be extra considerate as we approach these family favourite events such as bonfire night and Guy Fawkes.

NHS Track and Trace App

The NHS have now released their long awaited Track and Trace app. This has not gone without glitches, with an estimated 16 thousand contacts not being informed correctly that they are due to isolate. However, there have been a large number of the UK residents signed up to the app that uses your Bluetooth and location technology to track your whereabouts and work out whether you have been in close contact with someone who has now tested positive. We would encourage all residents to look into the app and how it may help protect our residents and neighbourhood.



We have had first hand experience now on using this app as well as many of the other services available once you have been traced as a contact. We have been contacted by track and trace and asked to isolate for 14 days which is a legal requirement. We have received several emails, text messages and a number of phone calls to check that we are in fact isolating, but more importantly I have noted the tone of the call is more about making sure that you are managing and doing okay both mentally and physically. It seems there is definitely a desire to understand where the virus is being caught and how it is operating in different age groups as well as making sure we are all doing our part to prevent the spread of Covid-19.
