SUBSCRIPTIONS

Welcome to the Spring 2018 edition of The Knoll News.

For those who are new to the area this edition is distributed to every household in The Knoll requesting payment of the 2017/18 subscription. This is still £1 per adult member of each household. Your Road Warden will call on you to collect the subscription but it helps them and speeds up the whole collection process if you could complete the form at the bottom of the Road Wardens names/addresses page (which you will find on page 4 of this newsletter) and pop the money through their door. The Summer and Autumn editions will only be delivered to households with a paying member.

2017 ANNUAL GENERAL MEETING

We had a very successful AGM on Tuesday, 21 November which well over 100 members attended, together with local Councillors, and invited speakers.

The meeting opened with a welcome from Rev Wendy Swann, assistant Minister of St John's United Reformed Church, whose hall we were of course using. Sergeant Nick McLoughlin provided an entertaining update of policing in the area. Sharon Baldwin, Executive Director of Orpington 1st, gave her usual enthusiastic and informative update of High Street developments. She also confirmed that Orpington 1st had been re elected to manage the Orpington business management district for a further 5 years from this March.

THE LONDON PLAN

Each Mayor of London publishes a London Plan setting out what they want to do during their term of office and beyond. It covers all the areas the Mayor has influence or control over, such as housing, planning, transport and the London economy. This Mayor is no exception and at the beginning of December Sadiq Khan published his London Plan. Details of the plan can be found at https://www.london.gov.uk/what-we-do/planning/london-plan/new-london-plan. The plan reports that the London economy is expected to grow and with this brings the demand for more housing, when there is already a shortage. The key points of concern for most of Greater London centre on the removal of protection for back gardens (contrary to national policy), the removal of the density matrix, the removal of targets for family homes, the reduction in parking standards and the insistence that new developments near transport hubs should have zero parking provision without exception. Cumulatively, these policies will encourage (particularly in outer London suburbs) a huge increase in the demolition of existing family housing and its replacement with blocks of flats with little to no parking provision. Furthermore the proposed London Plan presumes in favour for all developments under 25 units and within 800m of a town centre boundary or a station. LBB would therefore be unable to prevent planning applications to redevelop a few houses or use gardens and build flats with no parking provision. Amenity space starts at 5 square metres per unit. This would affect around 80% of The Knoll area.

We are obviously concerned that Orpington, as an area with principally family homes, will be redeveloped in to an area of flats without parking facilities. Whilst this works for inner London in close proximity to good transport links, we cannot see it working for Orpington. Whilst train links in to London are good, if overcrowded and rarely on time, getting anywhere else at speed, even with a car, is hard to achieve. There is clearly a shortage of homes for first time buyers, but unless house building is carried out with sense and a proper plan, then replacing family homes with flats only causes a shortage of properties to move on to when these households expand in size.

The Draft London Plan will need to go through several stages before it comes into force. The initial consultation, which finished on Friday 2nd March, was the first stage. It will go through several re-drafts, it will be interrogated by the London Assembly's Planning Committee, an examination in public and a vote by the London Assembly (who can vote it down, but only if two-thirds of the voting Members agree to do so) before requiring the sign-off of the Secretary of State for Housing, Communities and Local Government. The total process is expected to take just under two years.

Unfortunately, as noted above, the consultation period for this document ended on 2nd March so we were unable to draw this to your attention before then. However, the KRA has made comments on your behalf. We have also met with Jo Johnson, who is supportive of our views, and contacted Gareth Bacon London Assembly Member for Bexley & Bromley, who, as the Leader, GLA Conservative Group, is similarly supportive. Andrew Boff AM, who is the Group's Planning and Housing Spokesman has made representations on behalf of this group, many of which support our own concerns.

We will keep you informed of developments.

PLANNING

The appeals against the developments proposed for 24 Keswick Road, 69 Broomhill and 23 The Drive have all been rejected. Unfortunately the appeal against the development at 75 Mayfield Road was successful.

You may be aware that back in October 2016 an application was made to demolish 18-44 Homefield Rise and replace these houses with four separate three and four storey blocks, totalling 103 flats. This was refused by LBB but has been appealed against and, at the time of writing, the decision has not been made. The outcome of this appeal is important because a similar, though smaller, development is being proposed for Knoll Rise where numbers 14-20 would be demolished and replaced by 58 flats in one block, which would vary in height between 3 and 5 storeys. This application has met with considerable local opposition and, as of 2nd March, there were over 100 objections recorded on the LBB website. The KRA is supporting residents in their objections, as are the local councillors and Jo Johnson. LBB would not be able to oppose this planning application under the London Plan as it currently stands.

COMMUNITY FUN DAY Saturday 9th June 2018 between 2pm and 7pm at St John's Church.


You are all invited to come along for an afternoon of fun and games, food and festivities at St John's Church, Lynwood Grove.

DAMAGED FOOTPATHS AND RUBBISH

We often receive complaints from members about the state of the footpaths and grass verges, especially following building work. LBB can recharge the cost of making good damage caused by third parties, but only if there is evidence to prove who caused the damage.

If you have building work and the builders damage the footpath or the verge then we would suggest you ask them to make good the damage. It is hardly an unreasonable request. If they do not or will not then we would suggest that if the footpath is damaged go to Report It on the LBB website at the following link http://www.bromley.gov.uk/report or https://www.fixmystreet.com/.

Less than £10 of compost and grass seed and ten minutes work will be more than enough to make good a damaged verge. We would encourage residents to take responsibility for their own streets, as you cannot rely on anyone else to!

Three girls, M, R and F, who call themselves 'the Lynwood Litter Collectors' certainly have. An abridged version of an email I recently received from them is set out below. What more can I say!

"Dear Knoll Residents Association

The last two Saturdays we have been picking up a LOAD of rubbish down the roads near where we live. We are trying to get our Community badge at Cubs and Scouts but we still like doing this for nothing as we are helping nature. We had the idea to collect rubbish because we saw a HUGE amount of rubbish dumped along the streets and we thought it was getting worse. We didn't like it. We are proud of what we are doing. Last week our black bag was so heavy that it was really, really hard to carry and it broke. This week there was less litter and we finished more quickly in an hour, but we still had a bag full.

We have a few suggestions to make:

80 pounds fine if you drop rubbish because it will make people stop doing it as they will lose money.

Ban cigarettes from the area as we see the ends of them everywhere along the road. If you have to smoke you should put the butts in the bin when you've finished.

Everyone should clear up outside their houses and the street by their houses. That will make this area not so polluted. We could have a clear up day! Everybody should pick up rubbish wherever they see it.

Stop using so much plastic.

Put more bins in the area so people do not dump it because there aren't bins.

If you clear up after your dog, don't be disgusting and throw the plastic bag with dog poo in bushes. Put more dog bins in the area.

If you have builders in your house, tell them to be clean and tidy as we find lots of rubbish outside those houses. They also drive along the grass and make the grass all messy. The rubbish is sometimes deep down in the mud. Tell them to make sure things don't blow off the skips. If it does, they should pick it up.

Please try to convince people to start picking up rubbish. We have to stop at the church, but we see more rubbish further ahead that we could get if we had more time.

Maybe we could have a local rubbish picker shop with everything you need to pick up rubbish for 50p or £1 each.

When people put out their plastic for recycling they should have a duty to make sure it doesn't blow away. Dustbin collectors should make sure they pick up EVERYTHING they drop.

Some people just throw their rubbish out of car windows or just drop it on the street. People should teach their children not to drop rubbish so they don't do it, and when grow up and they're adults, they'll teach their children too. And so on!

Please could you help us to keep our streets clean! We can't go out collecting this weekend because of the snow.

We hope you can help make changes.

THE KRA MAY BE EXPANDING!

At the end of Lynwood Grove is Crofton Lane (specifically the houses between the railway bridge and opposite St Johns Road). Red Cedars Road leads from Dale Wood Road and off this road are 2 other roads: Pondwood Rise and Clay Wood Close. These roads are not currently covered by any residents association and there has been some interest in these residents joining the KRA as the nearest neighbour.

This edition will be distributed to all these roads and, depending on interest, the constitution will be amended at the AGM in November to include these roads. We hope enough residents sign up to join the KRA to make their inclusion worthwhile.

LOCAL ELECTIONS

There are local council elections on 3rd May.

Along with Gosport, Swindon, Watford and Woking, the London Borough of Bromley has volunteered to take part in a trial that will mean voters within the borough will need to show ID before they can vote. This is the first in a series of pilots to allow the Electoral Commission and Cabinet Office to evaluate the impact of asking for ID before a decision is taken on whether or not to roll it out nationally. Cards are being distributed in the borough advising what ID is required.
