2018 ANNUAL GENERAL MEETING

We had a very successful AGM on Tuesday, 20 November which well over 100 members attended, together with local Councillors, and invited speakers. Thanks to all the members who turned out on a particularly foul evening.

The meeting opened with a welcome from Rev Jennifer Millington Minister of St John's United Reform Church, whose hall we were of course using.

Sgt Blewer introduced himself as the new officer in charge of our local Safer Neighbourhood Team and provided an update on crime in the area.

Sharon Baldwin, Executive Director of Orpington 1st was scheduled, but unable to attend, so provided an update on the High Street which was read out at the meeting by the Chair on her behalf.

The main speaker was Gareth Bacon, the London Assembly member for Bexley and Bromley who provided an update on the London Mayors Plan. He is already booked to return for our 2019 AGM to provide the final update on this.

ANNUAL MEETING WITH OUR COUNCILLORS

THE LONDON PLAN

As a reminder, the London Plan is the statutory spatial development strategy for the Greater London area that is written by the Mayor of London and published by the Greater London Authority. The current Mayor published his first draft plan in December 2017 which was followed by a consultation period which ceased on 31 March 2018. Since then the plan has been modified, though not substantially, and is due to be presented to Secretary of State for Housing, Communities and Local Government (currently James Brokenshire) for final approval in a process commencing in April. As the Labour party has a majority in the Greater London Authority it is only at this level some of the concerns arising from the plan can be addressed.

The key points of concern for most of Greater London centre on the removal of protection for back gardens (contrary to national policy), the removal of the density matrix (this is designed to ensure developments are appropriate for the location and PTAL (public transport accessibility level) of the development), the removal of targets for family homes, the reduction in parking standards and the insistence that new developments near transport hubs should have zero parking provision without exception. These policies will encourage (particularly in outer London suburbs) a huge increase in the demolition of existing family housing and its replacement with blocks of flats with little to no parking provision. Furthermore, the proposed London Plan presumes in favour for all developments under 25 units and within 800m of a town centre boundary or a station. LBB would therefore be unable to prevent planning applications to redevelop a few houses or use gardens and build flats with no parking provision. Amenity space starts at 5 square metres per unit. This would affect around 80% of The Knoll area. The plan also encourages boroughs to permit taller properties.

We are obviously concerned that Orpington, as an area with principally family homes, will be redeveloped into an area of flats without parking facilities. Whilst this works for inner London in close proximity to good transport links, we cannot see it working for Orpington. Whilst train links into London are good, if overcrowded and rarely on time, getting anywhere else at speed, even with a car, is hard to achieve. There is clearly a shortage of homes generally and in particular for those starting on the housing ladder but unless house building is carried out with common sense and a proper plan, then replacing family homes with flats only causes a shortage of properties to move on to when these households expand in size.

AREA OF SPECIAL RESIDENTIAL CHARACTER (ASRC)

As a recap, the following criteria should be considered in determining whether an area qualifies as an ASRC

- (i) there should be a sufficient number of properties to form an area of distinctive character. The area should be well established, readily identifiable and coherent
- (ii) the majority of properties should generally have the same readily identifiable characteristics (e.g. high spatial standards, similar materials, well-landscaped frontages)
- (iii) the boundary should be easily defined and defensible and
- (iv) the areas defined should be primarily residential in character

As you may recall back in 2016 the KRA took a poll from residents on whether they would like their road categorised as an ASRC. Those roads where a majority of the residents had voted in favour of inclusion in the ASRC were then included in the KRA's formal application to LB Bromley. LBB considered the application and ruled out certain roads as their characteristics did not fulfil the necessary criteria. The remaining roads formed the ASRC which was included in the London Borough of Bromley's own plan. After consultation the Bromley Local Plan was the subject of an examination by an independently appointed Inspector. In her report published in December 2018, the Inspector confirmed that the Local Plan was sound subject to a number of main modifications.

The modifications recommended by the Inspector, together with additional minor modifications, are included in the adopted Bromley Local Plan which was finally adopted on 16 January 2019. This final plan confirmed that part of the Knoll was duly designated as an ASRC. The roads concerned are Lynwood Grove, Mayfield Avenue and Broxbourne Road, plus the side roads off these roads and the majority of Dale Wood Avenue. Now that part of The Knoll has ASRC status what does this mean? It means that in considering planning applications the Council will pay particular attention to the following development control guidelines

- 1. Developments likely to erode the individual quality and character of the ASRCs will be resisted
- 2. Residential density shall accord with that existing in the area
- 3. Spatial standards of new development (plot width, garden depth and plot ratio) shall accord with the general pattern in the area
- 4. The general height of existing buildings in the area shall not be exceeded
- 5. The space between a proposed two or more storey development and the side boundary of the site should accord with that prevailing in the area
- 6. Backland development will not be permitted
- 7. New development will be required to take account of existing front and rear building lines
- 8. Existing mature trees and landscaping shall be retained wherever possible
- 9. Conversions, where appropriate, will only be acceptable where they do not alter the external appearance of the building
- 10. Proposals, including conversions that are likely to significantly increase the proportion of hard surfacing in front of existing properties, will be resisted unless accompanied by satisfactory landscaping proposals materials shall match or complement those in adjoining existing developments
