#### Priory Live makes a comeback and its better than ever! – Steve Sangster

Orpington's biggest music festival returns for its fourth year in Priory Gardens this summer. KRA's Stephen Sangster met the organiser Nick Barclay to get the lo-down.

The festival has been created to celebrate original music from local bands and artists and is headlined by 90s favourites Toploader. A big win for Orpington from a band who has sold 2 million albums which includes the very catchy "Dancing in the Moonlight" number which will no doubt have everyone up on their feet!

But it's not all just about the music, Nick explains there will be a selection of great 'world' food outlets from Caribbean to Pie and Mash! Also, a new idea for 2021 is a 'creative makers' market that will feature artists, designers and creatives who produce their own work. He wants to create a festival that all the family can enjoy.

Nick goes on to say that there will be a main stage where the artists will perform for 10 hours but also a BBC Upload Stage hosting comedy, poetry and music where you get the chance to upload and appear. #### The Walnuts Development - Anika James

This edition we're shining a spotlight on the development that's got everyone talking. Our Committee members headed down to the consultation event earlier this month to get the latest, and we've been polling our residents on Facebook to find out what you like and what you don't like about the proposals so far.

#### What's the plan?

A complete overhaul of the entire Walnuts area, retaining the existing cinema and hotel but demolishing and rebuilding the leisure and shopping centre and introducing more housing into the town centre. Plans for the new build include:

- Homes for around 2,000 people (in high rise buildings)
- New leisure centre and Saxon day centre
- Variety of units for shops, restaurants and workplaces
- A civic square, market street and market plaza
- New walk-through layout connecting all four sides, from the high street to Lych Gate Road and Homefield Rise to Dryden Way

#### What the developers told us about their plans









- Area will be fully pedestrianised pedestrians and mobility scooters - no bikes). There will be 300 public parking spaces, 350 separate spaces for residents of the new buildings and 1,800 cycle storage spaces.
- Retailers will be incentivised to come to Orpington (and stay here) with a pioneering, flexible rental model based on turnover.
- New leisure centre pool will be 25m long (current pool is 33m). We understand this length would conform to current standards for swimming club competitions although it would significantly reduce overall capacity for general swimming. Local community gym usage and needs are under review, but they expect a set-up and equipment more in line with other gyms in the high street.
- Construction programme phases are yet to be decided (these are subject to planning) but they expect the Saxon day centre to remain open throughout.
- Social housing provision is also yet to be set, but the aim is to provide 'as much as possible'.

#### What do your fellow Knoll residents think?

We posted two opinion polls on the KRA Facebook group, asking members to indicate their concerns, and also what they like about the proposals. Multiple votes







"I marched down there ready with all my points and concerns. But I came away in gareement. Yes, the "tower" could be less floors but I'm not sure it really changes a huge amount...they are investing £460m and I think that's good for the community." - Jenny

"It looks progressive and could cater to many future needs if we get this right. We have to accept that more people are coming to live here and as much as I love Orpington the way it is, I accept that there will be changes." - Patsy

"Given the huge pressure that Boroughs are under to create new homes given the "London Plan" it is better in my opinion to create town centre homes rather than have to fight the repeated development requests in Knoll Rise." - Eric

"I don't think any would argue that the Walnuts and Leisure Centre needs investment. Some of the ideas such as smaller commercial units with flexible rent and the indoor market should bring new creative ventures and much needed vibrancy into the high street." -Marie



"The high-rise block is out of character for the area, out of scale (Orpington is a low-rise town) and will completely alter the existing character of the town, which is largely 1930s and two storeys high. This building would become a precedent to further high-rise buildings in the future." - Chris

"I think it will impact the outside seating area of some of the coffee shops, bars and restaurants on the High Street as I am sure something that size will take away sunlight. Also, there's the impact on traffic, car parking, schools, doctors appointments and our hospital that will definitely impact on us all." - Liz

"Most young people cannot afford the deposits for such flats." -Hillary

"The new pool will be smaller and will take over two years to construct." - Elizabeth

"Families don't want to live in tower blocks. We do desperately need more social housing but I expect these plans will be for private and so called affordable housing" - Linda

#### Walnuts Development - What does your MP have to say?

Dear Mr Sangster,

Thank you for your e-mail dated 19th June on behalf of KRA. I likewise hope you and yours You are welcome to use the following quote from me on this matter at this early stage of the process:

"I have sympathy with the idea of regenerating the town centre in principle, particularly as there is considerable potential to bring benefits that boost our local economy and aid our long-term recovery from the still on-going pandemic.

The decision on the planning application - which has not yet been submitted - will be taken by Bromley Council. As per planning policy, there will then be a formal stage for consultation where all residents will be able to make their views known, and I would encourage you to do

While MPs do not have any formal powers in the planning process, I have made my concerns about issues such as high-rise developments and a lack of parking spaces very clear directly with the Chief Executive Officer of Areli, and stressed the downside and potential local opposition that could well be aroused by an attempt to mimic central London because the character of Orpington is markedly different.

You may be interested to note that, following the recent public presentation, Areli have published their proposals online and are inviting public views on their regeneration plans.

Areli have said these will be taken into account, so this is your opportunity to help shape the future of Orpington town centre before the formal submission of the planning application to Bromley Council.

The regeneration of the Walnuts Shopping Centre will have a huge impact on our high street right so have your say to ensure we have Orpington: https://thewalnutsorpington.co.uk/have-your-say/

This process has a long way to go before final decisions are made and I will be monitoring it very closely.

#### **Conclusions**

However residents feel about the proposals, there appears to be a general consensus that the town centre is run down and needs investment.

Bromley Council has a target of 774 new homes every year as part of the London Plan and with concerns about green belt land development and multiple occupancy conversions in our roads, the centre of town may just be the compromise we need for local housing in Orpington.

Your biggest concern, with almost more than twice the votes cast than for any other issue, was the proposed height of the multi-storey residential buildings (current proposals include 19 and 24 storey buildings - for comparison, the College is 12 storeys high).

High rise residential of some sort is the price to pay for the improved facilities, retail and community spaces. What remains to be seen is just how high is too high for local residents and the Council, and whether lower buildings would give a big enough profit margin to make the whole scheme worthwhile for the developers.

#### What happens next?

We are arranging a KRA Committee briefing with the developers to take place before they apply for planning permission.

We will also be seeking comfort from the Council that, should the development go ahead, they will ensure the developer delivers all the promised community spaces (not just the residential units) as well as provide all the necessary supporting infrastructure.

We will keep you up to date with what we learn on our Facebook page.

#### Boundary Commission for England - Steve Sangster

The Boundary Commission is proposing to change some of the existing Parliamentary constituency boundaries.

In London they are looking to increase the number from 73 to 75, as far as possible having regard to local ties, geographic factors, local government boundaries and existing constituencies.

It is initially proposed that Petts Wood & Knoll ward will no longer be in Orpington constituency but moved into a new constituency called Bromley.


(The Commission has used the unrevised ward boundaries to draw up its plans so in effect it is Petts Wood and part of the Knoll to which it refers. The KRA and local Councillors will draw this to the Commission's attention.)

Bromley & Chislehurst constituency will disappear to be replaced by Bromley constituency and Eltham & Chislehurst constituency.

We polled KRA residents on this issue via Facebook and at the time of writing, 87 residents had responded. 91% said they would like to stay in Orpington constituency. 4% said they would like to move into Bromley constituency. 5% were undecided.

The closing date for comments via the Boundary Commission website, www.bcereviews.org.uk is 2nd August 2021.

There will be two further rounds of consultation in 2022.



We encourage residents to provide feedback on the above link. The KRA will also be making representations based on the resident feedback received.

As you can see, and to compare them with previous months, the  $\it Reported\ Crimes$ 

for May/June are pretty low and the highest figures (Common Assault) may be down to licensed Premises having re-opened. Without wanting to curse these stats, in my 10 years plus on Petts Wood & Knoll I've never known the figured to be as low, so this pretty good!!!

Now that we are coming out of lock down and with the potential of *Travel* just around the corner, properties are more likely to be left unattended, so we ask residents to look at ensuring that when properties are left they ensure that *Alarms* are set and windows and doors secured. Lock the rear garden gate. Remove any cycles from the garden, ensure that you secure the Garage/Garden Shed/Summer House and remove any garden tools that may have been left out and could potentially be used to break into your property. Try to ensure that items cannot be seen from outside of the buildings. If they can be seen and are of any value then the criminal only has to break into the building which is more likely to be easier to do so than your main building.(Possibly use *Window Netting*)

If you are going away in your vehicle this may possibly be leaving your front drive, where you usually leave your vehicle, empty. Why not speak with a neighbour who you are happy with and ask them if they want to park one of their vehicles on your drive! Think about setting up Light Timer switches; one downstairs and one upstairs.

Whilst you're away, see if you can arrange for a family relative or trusting neighbour to come in every few days to remove any mail that may have been delivered and on display, or hanging out of letter boxes. Also maybe ask them to enter your property to adjust your blinds/curtains to make it look as if there is someone at home.


